***Saddleback College off the 5 fwy @ Avery Pkwy. Parking Lot 9**

***No vehicles may enter the shopping area after 7:30 am or leave before 3:00 pm**

IMPORTANT STUFF TO KNOW!

***Vendors to park no more than one vehicle horizontally in the back of their space in Lot 9 (vehicle must fit in rented space).**

***Additional vehicles must park in Lot 9A.**

***No moving vehicles are allowed in the market area between 7:30 am and 3:00 pm per MV Fire Dept.**

***Vendors may begin to exit the market at 3:00 pm. Please be kind and try and keep the aisles clear for through traffic.**

***All vendor spaces MUST be clear of all items and trash by no later than 5:00 pm. (if you leave trash behind, we'll leave you behind too).**

***No overnight sleeping in vehicles on Saddleback College campus.**

***NO SMOKING OR DRUG & ALCOHOL USE ALLOWED**

CA SELLER'S PERMIT

***All regular vendors are required by law to have a California Seller's Permit. Visit www.boe.ca.gov or call 1-800-400-7115.**

Occasional vendors may sell twice in a 12-month period without a seller's permit.

ABOUT THE GOODS:

***Merchandise to be sold must be vintage, antique, collectible, or at least 30 years old, or art and objects made with vintage flair.**

***The Coast prohibits the sale of firearms, ammunition, fireworks, porno, contraband, ivory, and endangered species.**

***Please display merchandise in a nice, neat, and interesting manner that will entice our customers. For instance, no merchandise may be sold straight out of cardboard boxes, display tables must be covered, and personal belongings, and packing supplies must be placed out of view. ***Vendor will supply own tables & canopies. No generators allowed.**
